APPROVAL OF APPLICATION

IT WILL TAKE 4-6 WEEKS

- 1. Meeting the education requirement;
- 2. Completing professional internship;
- 3. Passing extensive examinations;
- 4. Completing the OAA Admission Course; and
- 5. Being a person of good character

In order to offer or provide architectural services in Ontario (as defined in the Architects Act) to the public, an individual must be the holder of a Certificate of Practice with the OAA.

Once licensed, architects can <u>vote</u> at the OAA Annual General Meeting, run for election to gain a voting seat on Council, volunteer on OAA Committees and Task Groups, as well as play a key role in training future architects.

The Experience Requirements Committee (ERC) determines if an applicant has met the experience requirements prescribed by the Regulations forming part of the eligibility requirements for the issuance of an OAA license.

REGISTRATION

CERTIFICATE OF PRACTICE

- 1. An architect in good standing with the OAA
- 2. Hold professional liability insurance
- 3. Comply with applicable regulations

Certificate of Practice to keep their records current and true.

Categories of Certificates of Practice

- 1. Corporation
- 2. Partnership
- 3. Sole Proprietor

Holder of Certificate of Practice:

51% of voting shares are owned by OAA architects/PEO engineers 49% of voting shares are owned by non-OAA architects/non-PEO engineers

SEAL

1. Physical

2. Digital: Through Notarius





- 1. Certificate of Practice has been approved
- 2. For an employee of a holder of a Certificate of Practice to be eligible for a seal, the Certificate of Practice holder must provide confirmation in writing to the OAA
- 3. For an employee of other than a holder of a Certificate of Practice (e.g. federal or provincial government, banks, etc.) to be eligible, the employer must provide confirmation in writing to the OAA indicating the seal will be used only for projects owned by the employer.
